NOTIFICATION

No.SOR-III(S&GAD)1-10/2020(P).- In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to make the following amendments in the Punjab Agriculture Department (On Farm Water Management) Recruitment Rules, 2003, with immediate effect:

AMENDMENTS

In the Punjab Agriculture Department (On Farm Water Management) Recruitment Rules, 2003, in the Schedule:

1. at Sr. No.18, for the post of 'Asstt. Director (Admn) (BS-17)', in column No.7, for existing entry, the following shall be substituted:

"By promotion on the basis of seniority-cum-fitness from amongst Superintendents (BS-17) with five years' service in the functional unit and have successfully completed promotion related training at Water Management Training Institute, Lahore.";

2. at Sr. No.31, for the post of 'Supervisor (BS-11)':

- (a) in column No.5, for existing entry, the following shall be substituted:

"(i) B.Tech. (Hons.) or B.Tech. (Pass.) in Civil or Mechanical Technology (second division) or equivalent qualification from a university recognized by Higher Education Commission; or

- (a) Secondary School Certificate (second division) from a recognized Board; and

- (b) three years' Diploma in Agriculture Engineering or Mechanical Engineering or Auto and Farm Machinery or Civil Engineering from an institute recognized by Board of Technical Education, Punjab."; and
