- 4. Bids must be submitted on or before **31-10-2016 at 11:00 a.m.** in the office of Director General Agriculture, Water Management, 21 Davis Road, Lahore.
- 5. Bids shall be valid for a period of 60 days after bid opening and must be accompanied by bid security of **Rs. 1.8 million** in shape of CDR/Bank Draft/Pay Order in favour of Director General Agriculture (Water Management), Agriculture Department, Government of the Punjab.
- 6. All bidders shall be required to submit with their bids, qualification information specified in the bidding documents. This information shall be used to establish thorough post-qualification whether the bidder is qualified to perform the work.
- 7. Bids are required to be submitted on item rate basis and the rates and amounts in (in Rupees) must be filled by the bidder for each item in the Bill of Quantities and provide a total price. Non-compliance may result in rejection of bid.
- 8. Bidders should give their best and final price in their bids as no negotiations are expected. A pre-bid meeting will be held on **18-10-2016 at 10:30 a.m.** in the office of the Director, Water Management Training Institute Punjab, Thokar Niaz Beg, Lahore for clarification and scope of works if any. All the interested contractors are invited to attend the meeting.
- 9. Site is situated at 4 Kilometer from Renala Khurd on Main G.T Road toward Okara and can be visited on any working day.

- 10. Bids will be opened in the presence of bidders or their representative who choose to attend at 11:30 a.m. on 31-10-2016 in the office of Director General Agriculture (Water Management), Agriculture Department, Government of the Punjab.
- 11. In case of any National/Provincial holiday on bid submission/opening date, the bids will be submitted/opened on the **next working day** at the same times and venues as mentioned at serial No. 4 and 10 above.
- 12. As provided in the bidding documents, bidders engaged in corrupt or fraudulent practices (including collusion/pooling) will be declared ineligible, either indefinitely or for a stated period of time, to be awarded a contract financed by the World Bank.
