NOTIFICATION

No.SOR-III(S&GAD)1-16/04(PI). In exercise of powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to direct that in the Punjab Agriculture Department (On-Farm Water Management) Recruitment Rules, 2003, the following further amendments shall be made:
